PLEASE NOTE:

- Purchaser must own the building and be the one who applies for the rebate.
- Rebates will be offered following installation, are subject to availability of funding, and offered on a first come, first served basis until the funds run out. Only qualifying purchases apply (see below for details).
- Attach the entire receipt, which must include the purchase date, brand, and model number, to the application. Keep a complete copy for your records.
- Attach photos of the item being replaced (model and serial number if possible), and of the new item after installation.
- Submit a completed application, completed affidavit (below), copy of your identification and entire sales receipt to your water provider **within 90 days of purchase date**. NO EXCEPTIONS.
- The application must be deemed complete by the Water District prior to being placed on the rebate payment list.

- Clothes washer** (\$100 rebate, limit 1 per residence)

- Weather-based smart controllers or ET-based controllers** (\$75 rebate, limit 1 per residence)

Failure to cash a rebate check within 90 days of issuance shall void the rebate and shall relieve the water district of any obligation or liability to pay the rebate. Rebate checks cannot be reissued. Dependent on available funds.

Rebates Must Meet the Following Restrictions:

- You must be a water customer of the Mount Werner Water District.
- Rebates apply to qualifying items and specified models only. No exceptions.
- Application forms without complete information or a valid receipt will be returned to the applicant.
- New construction (including additions) does **not** qualify, remodels and retrofits do apply.
- New toilet must replace an existing toilet that uses 3.5 gallons (pre 1994) or more per flush
- New toilets must have EPA WaterSense label and be 1.28 or less gallons per flush
- The rebate applicant must be the purchaser of the fixture and owner of the building
- All application forms must be accompanied by a valid sales receipt. A valid receipt shows purchaser name, installation address, date purchased, manufacturer name/make, model number and the price for each item. The valid receipt must indicate the item is paid-in-full.
- Online purchases must show the manufacturer make and model of the appliance or fixture. Purchases must show a "paid" status.
- If you live in an apartment or condominium, contact the management office or HOA, and obtain your water account number.
- All applications must be accompanied by proof of lawful presence (affidavit) in the United States.
- All rebate applications must be submitted within 90 days of the purchase date. No exceptions.
- Only new fixtures or appliances qualify. Fixtures/appliances that are used, leased, refurbished, rented, received from warranty or insurance claims, exchanged, or won as a prize do not qualify for this rebate.
- Customers applying for a rebate must agree to allow Water District employees to access their properties in order to verify installation of devices eligible for rebates.
- Failure to cash a rebate check within 90 days of issuance shall void the rebate and shall relieve the Water District of any obligation to pay the rebate. Rebate checks cannot be reissued.
- Make a copy of the entire application, receipt, and affidavit, and keep the copy for your personal records.

Rebate Criteria

High-efficiency Toilets (\$150 rebate for commercial (maximum \$1,050); \$100 rebate for residential (limit 2 per residence))

- Rebates are for replacement of toilets manufactured before 1994 that use 3.5 gallons / flush or more. Only EPA WaterSense-labeled toilets that use 1.28 gallons per flush or less listed at www.epa.gov/WaterSense/product_search.html are eligible for rebate. The WaterSense logo must appear on the toilet.
- Limit 2 toilet rebates per residence.
- Low-flow toilets (1.6 gallons per flush) do not qualify for rebate.

High Efficiency Clothes Washers (\$100 rebate, limit 1 per residence)

- Replace your 2000 or older model clothes washer with a high efficiency model. Only Tier 3 models listed by the Consortium for Energy Efficiency (CEE) at www.waterenergysavings.com are eligible.
- Limit 1 clothes washer rebate per residence.

High Efficiency Dishwashers (\$75 rebate, limit 1 per residence)

- Replace your 2002 or older model dishwasher with a high efficiency model. Only models listed at www.energystar.gov are eligible and electricity and water usage must not exceed the following maximum level: 307 kWh/year and 5.0 gallons/cycle (residential) – provide copy of tag.
- Limit 1 dish washer rebate per residence.

Irrigation Retrofits (up to \$75 rebate for residential; up to \$1,000 Commercial or HOA) MUST SUBMIT AN IRRIGATION PLAN FOR APPROVAL. For assistance call 970.879.6323.**Rain sensors**

- Rain sensors that connect to an automatic, in-ground irrigation system are eligible for the rebate (see list at www.mwwater.com)
- One time rebate per property.

Rotary nozzles or High efficiency spray heads

- Eligible models include Hunter MP, Rain Bird, and Toro Precision rotary nozzles. See qualifying model list at www.mwwater.com for full details.
- One-time rebate per property.

Weather-based smart controllers or ET-based controllers

- See qualifying model list at www.epa.gov/WaterSense/product_search.html.
- Limit 1 weather-based smart controller rebate per residence. Commercial must show multiple controllers on plan.
- Some smart controllers operate based on historical information, while others operate based on current weather data transmitted each day from local weather stations or on-site data during the irrigation season. Prices vary depending on the model, brand, and vendor.
- Equipment cost and labor must be separated on receipt.

Xeriscape

- Rebate is for replacement of existing irrigated turf with indigenous drought tolerant plant or non-irrigated xeriscape “garden” using the seven xeriscape principals. (see plant list www.mwwater.com). A landscape plan must be approved and followed.
- Amount of rebate will be up to \$75 on a square footage basis (e.g. 100 sq.ft. = \$34.)

State law requires you to prove lawful presence in the United States in order to receive the benefit of the rebate.**At the time this form was printed, forms of identification acceptable to the Colorado Department of Revenue include:**

- a valid, current Colorado driver’s license;
- a valid, current Colorado identification card;
- a valid, current driver’s license or identification card with applicant’s photograph issued by one of the following; Alabama, Arizona, Arkansas, California, Connecticut, Delaware, District of Columbia, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Minnesota, Mississippi, Missouri, Montana, Nevada, New Hampshire, New Jersey, New York, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Virginia, West Virginia, and Wyoming;
- United States Passport (except “limited” – issued for 5 years or less);
- a United States military card;
- a United States military dependent’s identification card;
- a United States Coast Guard Merchant Mariner card;
- Native American tribal document;
- a naturalization or citizenship certificate;
- an I-94 immigration form with refugee or asylum status; or
- an unexpired resident alien card, permanent resident card, temporary resident card, or employment authorization card;
- any other form authorized by the Colorado Department of Revenue.

Please mail a photocopy of your identification (in one of the forms listed above) and your signed affidavit along with the other rebate paperwork. We assure you that this information will remain confidential. You may remove/darken all sensitive information such as driver’s license numbers or social security numbers from the copy of your ID that you submit. Expiration date must be visible.

In addition, you must sign below and return affidavit;**AFFIDAVIT OF LAWFUL PRESENCE IN THE UNITED STATES**

I understand that state law requires me to provide proof that I am lawfully present in the United States prior to receipt of this public benefit. I further acknowledge that making a false, fictitious, or fraudulent statement or representation in this sworn affidavit is punishable under the criminal laws of Colorado as perjury in the second degree under Colorado Revised Statute 18-8-503 and it shall constitute a separate criminal offense each time a public benefit is fraudulently received.
